

PUTNAM COUNTY RETIRED TEACHERS' MEETING MINUTES  
May 14, 2019

The meeting was called to order at 12:03 PM by President Alan Zerkel. There were 15 members present and 2 visitors. Alan introduced Lynn Cox our Area 4 representative. She is from Martinsville and taught for 30 years. The following points were discussed:

- Information regarding the new bill for teachers that will require them to perform 15 hours of community service during the summer, unless documentation of these activities is turned in prior to the end of the school year. This requirement is connected to the license renewal process.
- The Representative Assembly is set for Wednesday, June 12<sup>th</sup>.
- The Indiana Retired Teachers' Foundation has the following programs: 1) They are working to be a self-funding endowment; 2) They have a \$2,000 scholarship that will be given to a college junior or senior; 3) There is a \$1,000 grant that will be given to a retiree; 4) There were 40 applications this year for the \$500 Active Teacher Grant.
- Giving Tree - if a person gives \$250.00 to the Retired Teacher's Foundation, they will what a red apple with their name on it hung on the tree.
- Retired Teachers did receive their 13<sup>th</sup> check. Lynn thanked those present who sent a letter to their legislature. We would not have this check without the work of Tom Mellish.
- Information was distributed to all present about a "Clear Captions" phone with a digital readout that is available free to retired teachers that have a cell phone and also a land line.
- Lynn reminded our organization that names of new officers for the year need to be sent to the state retired teachers' organization.

The members were given time for comments and questions. Alan gave the meal blessing.

Business Meeting

- The approval of the April minutes will be held until the September meeting as members present had not taken the opportunity to review them. They are posted on the web-site.
- Treasurer's Report: \$664.04 left after presenting the \$500.00 Scholarship. The scholarship money came from \$180.00 donated by Putnam Inn, \$247.00 collected from members donations, and \$84.00 collected from the 50/50 drawings.

- Maureen Wagner has agreed to plan programs for our meetings next year.
- Kenneth Houser won the 50/50 drawings - there was a total of \$13.00 collected.
- Ben Chadd shared information about "OLLI" trips through ISU for those over 55.
